We are doing well. Group practices are thriving, sincere and going in the right direction. Kyol Che is coming up. We developed a shortened version of the traditional 90-day retreat that is more suitable for our lay Sangha. Urge everybody to attend. Reviewed Kyol Che structure. Theme this year is our Chinese ancestors, particularly from the Tong dynasty.

Treasurers Report:

We are very healthy financially. We are a 501(3)(c) and contibutions are fully tax deductable. We bought down the loan a bit when we refinanced to maintain the same monthly payments. The heating system runs on propane and the roof will both need to be replaced at some point and will be major expenditures.

Committees:

Building and grounds. Dormant right now. Added cement stairs out back. Handrails to be added soon. The boiler is on borrowed time and propane is expensive. We want to replace with a heat pump. Not all heat pumps are suitable for in-floor heating. The exterior wood refinish. We are lucky to have the beautiful natural wood, but it is more difficult to maintain. The interview door was the most weathered.

Finance committee

Had a generous donation of TSLA stock which went up before we sold it. We have most of our funds in a 4.5% in a money market.

Board Nominations:

Ten board members authorized. Right now we have 9 members and the board recommends maintaining that number. When Jim became HDT that opened up his at-large seat.

Deborah and Joanne are stepping down as their terms expire.

The board recommends John be reelected and Meg, Bob K and Julie be elected. Paul introduced the nominees. Each nominee had the mic for a quick introduction.

Deborah nominates John, Rebecca seconds, no further discussion. Passes unanimously.

Jordan nominates Julie, Rebecca seconds, no further discussion. Passes unanimously.

Beth nominates Meg, Bob K seconds, no further discussion. Passes unanimously.

Meg nominates Bob K, Deborah seconds, no further discussion. Passes unanimously.

New Business:



Work practice. Work practice is a great way to maintain a meditative mind while simultaneously performing appropriate function. Also, have spontaneity in your personal work practice...if you see something that needs doing, do it. We have list of tasks. Would like a link to it on our website. Justin volunteers to help with tools. Teachers group will discuss this further.
